

Algoma That Real Fly Fishing Contest

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. LIMIT OF ONE ENTRY PER PERSON. ENTRIES EXCEEDING MORE THAN ONE WILL BE DISQUALIFIED FROM THE GRAND PRIZE. VOID WHERE PROHIBITED BY LAW.

General:

1. Algoma Kinniwabi Travel Association, Ontario Tourism Marketing Partnership Corporation and Jencor (the "Sweepstakes Sponsors") are offering Win your dream fly fishing trip (the "Sweepstakes") which will begin on or about December 24, 2016 at 12:00:01 am Eastern Standard Time ("EST") and will end on April 15, 2017, at 11:59:59 pm EST (the "Sweepstakes Closing Date").
2. By entering the Sweepstakes, entrants accept and agree to be bound by the Sweepstakes Rules and Regulations, and accept the decisions of the Sweepstakes Sponsor as final and binding in all respects.

Eligibility:

3. The Sweepstakes is open only to legal residents of Canada and the 50 United States (and the District of Columbia) who are at least 21 years of age or older at the time of entry. 4. Boat, motor and gas at the lodge of your choice
5. Fly fishing prize package including fly rod, fly reel, fly line, flybox, flies, New Fly Fisher ball caps, New Fly Fisher fleeces, stickers and DVDs. Value of this fly fishing prize package is approximately \$1000

The Grand Prize winner and his/her travel companion will be responsible for obtaining any required travel identification and documents and any health or insurance coverage, other meals, other entertainment, souvenirs, local and long distance telephone calls, gratuities, applicable taxes, incidentals, and all other expenses not specifically mentioned as included. 12. The selected entrant will be notified by telephone within approximately seven (7) business days of the Draw ("Notification").
